

# 10 QUICK TIPS FOR SELECTING AN ASBESTOS ATTORNEY



When you begin your search, keep in mind that a good asbestos attorney:

1. Knows a lot about mesothelioma and other asbestos-related diseases

4. Travels to you
5. Charges you on a contingency basis (no fee unless a settlement is obtained)
6. Provides you with copies of important documents
7. Does not work through a broker
8. Does not appear in late-night TV ads
9. Makes no unrealistic promises
10. Has a website presenting open, honest information

## INTERNET SEARCHES FOR AN ASBESTOS ATTORNEY: BEWARE

The internet ads when you search “asbestos attorney” or “mesothelioma attorney” will yield a mixed bag of results. Along with a handful of websites for the relatively small number of attorneys in the U.S. who excel in mesothelioma cases, there will be many sites for “attorneys” who are really case brokers who will sell your case to a “real lawyer” for a fee.

Carefully read through all the legal information lawyers provide on their website. Lawyers who provide good, thorough information are more likely to be legitimate asbestos attorneys who will be a good fit. Distrust lawyers who say little more than, “I can get you millions right away—trust me.”
